
AMERICAN RESCUEPLAN ACT (ARPA)

A COMMUNITY FORUM TO DISUCCS THE STRAGETY & SPENDING PLAN FOR ARPA FUNDS WEDNESDAY, MAY 4TH, 2022

BACKGROUND

On March 11, 2021, President Joe Biden signed the American Rescue Plan Act ("ARPA"), a substantial federal stimulus bill addressing many aspects and impacts of the COVID-19 pandemic. One component of the bill is the "State and Local Fiscal Recovery Funds" portion, which allocates approximately \$350 billion in one-time federal funds directly to state, local, territorial and tribal governments. The City of Colusa's share of the funding is roughly \$1.4 million, as calculated by the Department of the Treasury. The intended use of the funds is to meet pandemic response needs and rebuild a more robust, more equitable economy as the country recovers.

The City of Colusa must present a spending plan to the State by 2024, showing a detail of how all monies will be spent by December 31, 2026.

Funding is sent in two (2) separate payments, one half which we received in 2021 and the second which we will receive in the next twelve months.

ELIGIBLE USES

- 1. To respond to the public health emergency or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
- 2. To respond to workers performing essential work during the COVID-19 public health emergency by providing premium pay to eligible workers;
- 3. For the provision of government services to the extent of the reduction in revenue due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year prior to the emergency; and
- 4. To make necessary investments in water, sewer, or broadband infrastructure.



INELIGIBLEUSES

- Deposit into Pension Fund
- Contribution to Reserves

COUNCIL APPROVED

We have currently spent ARPA funds in the amount of \$271,311.00. This total accounts for the following:

- City Staff Essential Worker One Time Payment, \$106,20
- (2) City of Colusa Police Dept. Vehicles, \$120,000
- City of Colusa Police Dept. Radios \$45,035
- City Hall technology/broadband upgrades \$75,000
