PUBLIC HEARINGS

10. <u>Subject:</u> Introduction and First Reading of Ordinance No. __ approving regulations of activities at the City Boat Launch Facility.

DISCUSSION: City Manager Cain explained enforceable fines, as stated in the proposed Ordinance.

PUBLIC HEARING OPENED and CLOSED at 6:27 pm with no public comments.

ACTION: Motion by Councilmember Ponciano, seconded by Councilmember Vaca to introduce, read by title only, and waive the full first reading of **Ordinance 550** - An Ordinance of the City Council approving regulations of activities at the City Launch Facility. Motion passed 5-0 by the following roll-call vote:

11. Subject: Fiscal Year 2021-2022 Comprehensive Fee Schedule

DISCUSSION: City Manager Cain pointed out the changes, with the effective date of July 1, 2021.

PUBLIC HEARING OPENED and CLOSED at 6:29 pm with no public comments.

ACTION: Motion by Councilmember Conrado seconded by Councilmember Reische to adopt **Resolution 21-29** updating the Fiscal Year 2021-22 Comprehensive Fee Schedule for the City of Colusa. Motion passed 5-0 by the following roll-call vote:

AYES: Ponciano, Reische, Conrado, Vaca and Hill.

NOES: None. ABSENT: None.

COUNCIL CONSIDERATION

12. Subject: Funding Source for Recreation Program

DISCUSSION: Economic Development Coordinator Levings discussed the results of the 170 surveys returned from the community. She explained the upcoming Recreation Program.

PUBLIC COMMENTS: Citizen Janice Bell inquired if the \$25,000 covers the maintenance of the pool.

Susan Meeker, Maxwell Park and Auxiliary expressed positive comments for the programs.

ACTION: Motion by Council Member Ponciano, seconded by Councilmember Conrado to amend, then adopt **Resolution 21-30** assigning General Funds to the City's Recreation Program. Motion passed 5-0 by the following roll-call vote:

AYES: Ponciano, Reische, Conrado, Vaca and Hill.

NOES: None. ABSENT: None.

13. Subject: Pirelli Building Purchase Sales Agreement

DISCUSSION: City Manager Cain pointed out the following key points of the Purchase Sale Agreement: \$50,000 non-refundable escrow fee, the city could back out of the agreement at any time and if the city does not get any grants, Pirelli Cable would come back to discuss negotiations. Economic Development Coordinator Levings provided a presentation of the project and the steps taken up to this point.

PUBLIC COMMENTS: Ed Hulbert, Colusa Industrial Properties noted the value of the land and encouraged council to move forward on the purchase.

Citizen Janice Bell stated she was a proponent for the project.

ACTION: Motion by Councilmember Vaca, seconded by Councilmember Conrado to adopt **Resolution 21-31** approving the acquisition of the Pirelli Cable Building with Purchase Sales Agreement signed by the City Manager. Motion passed 5-0 by the following roll-call vote:

AYES: Ponciano, Reische, Conrado, Vaca and Hill.

NOES: None. ABSENT: None.

14. Subject: Consideration of amending Ordinance 519 (Commercial Cannabis Ordinance)

DISCUSSION: City Manager Cain discussed necessary amendments to meet the state regulations. Cain asked council to discuss store-front dispensaries, fees, development agreements and a timeframe. Attorney Jones explained the process to amend the Ordinance.

PUBLIC COMENTS: Aurora Ramirez, owner of Smoothing Hands Massage Therapist spoke in favor of a store-front dispensaries.

Citizen Janice Bell expressed her opposition against recreational retail store-front dispensaries. Cody Pine, owner of Sticky Trees commented on updating the Ordinance 519.

ACTION: There was council consensus to bring back Ordinance 519 with amendments related to commercial cannabis, state guidelines and store-front dispensaries.

FUTURE AGENDA ITEMS

Councilmember Ponciano requested two (2) council members be assigned as Colusa Industrial Property (CIP) liaisons. Ponciano and Conrado both volunteered.

Mayor Hill requested Colusa County Partnership One-Stop council member assignment.
