# CITY COUNCIL REGULAR MEETING MINUTES April 6, 2021 6:00 pm

CALL TO ORDER / ROLL CALL Mayor Hill called the meeting to order at 6:03 pm. Present: Council Members Ponciano, Reische, Conrado, Vaca and Hill.

## **COUNCIL CONSIDERATION**

6. <u>Subject:</u> Colusa Industrial Park (CIP) Subdivision Final Map 01-20 and deferred Improvement Agreement.

DISCUSSION: City Manager Cain explained the subdivision map and the deferred agreement for the streets. Ed Hulbert expressed his appreciation on the city's flexibility for the improvements.

ACTION: Motion by Councilmember Vaca, seconded by Councilmember Conrado adopting **Resolution 21-19** approving the recordation of a final Subdivision Map 01-20 to subdivide approximately 50.50 acres for the Colusa Industrial Park APN: 015-130-106 and approving a Deferred Improvement Agreement to satisfy certain Planning Commission conditions and approval. Motion passed 5-0 by the following roll-call vote:

7. Subject: Citywide Pavement Management Plan

DISCUSSION: City Engineer Swartz discussed the two proposals and recommended Pavement Engineering. City Manager Cain answered council questions about the need for alley repairs. Cain commented on the 10% franchise tax the city receives from Recology to help with road/alley repairs and that the city does patch potholes in alleys.

ACTION: Motion by Councilmember Ponciano, seconded by Mayor Hill adopting **Resolution 21-20** authorizing the City Finance Director to appropriate funds for a Pavement Management Plan and the City Manager to execute an agreement for services. Motion passed 5-0 by the following roll-call vote:

8. Subject: Social Media Policy Review

DISCUSSION: City Manager Cain explained the update in the employee and council handbook meets the state laws and regulations on social media.

ACTION: Motion by Councilmember Reische, seconded by Councilmember Vaca approving the Social Media policy changes for the City Council and City Staff. Motion passed 5-0 by the following roll-call vote:

9. <u>Subject:</u> Consideration of the Resolution authorizing of City Manager to sign the contract with Smith and Newell for audit service to the City of Colusa for two years.

DISCUSSION: City Manager Cain stated two companies applied for the Request For Proposal (RFP). Because, Smith and Newell have a long history with the city and the State confirmed there was a different manager to oversee it, the city could hire Smith and Newell again.

ACTION: Motion by Councilmember Conrado, seconded by Councilmember Vaca adopting **Resolution 21-21** approving and authorizing the City Manager to execute contract for Professional Auditing Services with Smith and Newell for Fiscal Years 2021-2022 for two years. Motion passed 5-0 by the following roll-call vote:

AYES: Ponciano, Reische, Conrado, Vaca and Hill.

NOES: None. ABSENT: None.

10. Subject: Consideration of conducting a new income study.

DISCUSSION: City Manager Cain reported the last income study was done in 2014. Cain explained the importance of a current income study for future funding.

ACTION: Motion by Councilmember Reische, seconded by Councilmember Vaca to authorize the City Manager to sign a new contract for an income study. Motion passed 5-0 by the following roll-call vote:
