19. Subject: Consideration of Local Early Action Planning (LEAP) Grant.

DISCUSSION: City Manager Cain provided information on this non-competitive grant.

ACTION: With no public comments, motion by Council Member Ponciano, seconded by Mayor Hill to adopt **Resolution 21-03** authorizing application for, and receipt of Local Government Planning Support Grant Program Funds. Motion passed 5-0 by the following roll-call vote:

20. <u>Subject:</u> Consideration to authorize Change Order #2 to R & R Horn General Contractor, Inc. for the 2020 Wastewater Improvement Project, SRF Loan Project No. C-06-7896-310, for the amount of \$61,465.01.

DISCUSSION: City Manager Cain reported on the details and the reason for the change order.

ACTION: With no public comments, motion by Council Member Vaca seconded by Council Member Conrado to adopt **Resolution 21-04** authorizing Change Order #2 to the contract for the 2020 Wastewater Improvements Project for the City of Colusa in the amount of \$61,465.01 which will change the contract amount to \$1,754,965.01. Motion passed 5-0 by the following roll-call vote:

21. <u>Subject</u>: Consideration to authorize a Change Order to the contract awarded to LIDCO Inc. in the amount of \$33,906.99 for the Farmland Drainage Improvement Project to reduce impact to existing irrigation system.

DISCUSSION: City Manager Cain reported on the details and the reason for the change order.

ACTION: With no public comments, motion by Council Member Conrado seconded by Council Member Reische to adopt **Resolution 21-05** authorizing Change Order #1 in the amount of \$33,906.99 increasing the contract award to LIDCO Inc., for the Farmland Drainage Improvement Project in the amount of \$584,710.82. Motion passed 5-0 by the following roll-call vote:

22. Subject: Consideration approving the application for the Prop 68 Per Capita Grant Funds.

DISCUSSION: Economic Development Coordinator Levings presented information on Prop 68 and that the grant was be used towards a new attraction at a park. She reported the majority of citizens at the community meetings wanted a Splash Pad and a Skate Park.

City Manager Cain stated the \$177,000 grant was to be used for new construction only and had to be community driven. The application deadline is March 14<sup>th</sup>.

City Engineer Swartz dispersed handouts of different themes and designs of Splash Pads and location at the park.

PUBLIC COMMENTS: Citizen Melissa Yerxa expressed positive comments towards a Splash Pad. Citizen Elizabeth Yerxa inquired about public participation from the Focus Groups.

ACTION: With no public comments, motion by Council Member Conrado, seconded by Council Member Vaca to adopt **Resolution 21-06** approving application(s) for Per Capita Grant Funds. Motion passed 5-0 by the following roll-call vote:

23. <u>Subject:</u> Consideration of a fee moratorium on building and plan check fees for the City of Colusa's downtown for one (1) year.

DISCUSSION: City Manager Cain discussed the downtown existing businesses on Main Street between 4<sup>th</sup> - 12<sup>th</sup> Street and Market Street between 2<sup>nd</sup> - 13<sup>th</sup> Street. At the January 19<sup>th</sup> meeting, Council requested six months, rather than one year.

PUBLIC COMMENTS: Newspaper Editor, Susan Meeker asked for clarification on the businesses facing the side streets.

ACTION: With no public comments, motion by Council Member Reische seconded by Council Member Conrado to adopt **Resolution 21-07** making an amendment on the Moratorium on Building and Plan Check fees for the downtown area from February 2021 to August 2021. Motion passed 5-0 by the following roll-call vote:

24. <u>Subject:</u> Consideration for Underwriting Consulting Service for Community Development Block Grant (CDBG).

DISCUSSION: City Manager Cain explained the CDBG requirement was to have a contract underwriter on staff to write grants and loans for customers.

ACTION: With no public comments, motion by Council Member Vaca seconded by Council Member Ponciano to adopt Council to adopt **Resolution 21-08** adopting the Underwriting Consulting Services Contract to Ben Felt & Associates for the City of Colusa Community Development Block Grant (CDBG).
