CALL TO ORDER / ROLL CALL Mayor Hill called the meeting to order at 5:30 pm. Present: Council Members Ponciano, Reische, Conrado, Vaca and Hill.

PUBLIC COMMENTS

Citizen Don Bransford expressed concern over the tourism fund and potential conflict of interest on fundraising activities.

Citizen and Business Owner Michael West discussed concerns on Item 8 and the cannabis retail store-front online survey.

Beth Young asked why the update on tourism, finances and warrants list was not on the agenda. Citizen Ben Felt requested reports on event income and expenses and consent items to be pulled. Devin Kelley, Elected Treasurer requested an update on the city's purchasing policy and council input on the new Rural Recreation and Tourism Grant.

PUBLIC HEARING

9. <u>Subject:</u> Continued Public Hearing regarding an overrule of the Colusa County Airport Land Use Commission determination of inconsistency applicable to the associated with the Colusa Industrial Properties Tentative Map 01-16 and related entitlements

DISCUSSION: Community Development Manager Stice provided details of his revised staff report and Resolution since the last council meeting. Jake Kyle with Colusa Industrial Properties (CIP) clarified that the developer had signed the avigation easements on the first 12 lots. County Community Development Director Plucker stated the 12 sold homes were removed from the

avigation easement. City Manager Cain stated Realtor, Ernie Phelan confirmed all 43 home buyers signed the easement.

PUBLIC COMMENTS at 6:47 pm:

County Community Development Director Plucker discussed the homes constructed in late spring were in a new area and did not have signed building permits. Plucker requested council provide clear direction in the future on state and local land use compatibility. Stice commented the city will follow the Airport Land Use Commission referral form process.

ALUC Chairman West commented on his letter to council, council's responsibilities on mitigation measures and the need for an updated Environmental Impact Report (EIR). He questioned how building permits were approved and issued.

Jake Kyle with CIP stated they have been trying to work with the airport.

Citizen Dave Meyers discussed safety in the airways and mitigation measures. Stice commented how mitigation measures were reviewed and were handled accordingly.

Mayor Hill called for a recess at 7:18 pm

Mayor Hill reconvened the meeting at 7:26 pm

Citizen Paul Sankey asked council to make the decision based on safety and expressed the need for a new EIR.

Citizen Bill Abel commented on the EIR and the statutory duty to submit to ALUC.

Citizen Pat Meyers asked why a new EIR wasn't done when CIP was incorporated.

Citizen Woody Yerxa commented on safety and to correct any mistakes now.

Citizen Devin Kelley asked about the assessment fees.

Wendy Tyler, County Administrator addressed the 2014 Airport Land Use Compatibility Plan. She stated that plan included the referral form. She asked council to think carefully and make the right decision.

Citizen Peter Lindquist discussed three measurements regarding sound. He expressed concern on safety and the airport.

ACTION: Motion by Mayor Hill, seconded by Council Member Reische to continue Public Hearing till November 2, 2021. Motion passed 5-0 by the following roll-call vote:

AYES: Ponciano, Reische, Conrado, Vaca and Hill.
