#### **DEFINITION**

Under general direction, to conduct a variety of complex building inspections of residential, commercial or industrial building structures and installations in various states of alternation, construction, and repair; to determine that construction, alterations, and repairs are in compliance with City, County, and Uniform Building Codes and ordinances; to perform commercial pre-occupancy inspections; to enforce and administer building and zoning codes and ordinances; to answer questions regarding code enforcement and structural requirements for the public, architects, contractors, and engineers; and to do related work as required. This position class is also responsible for the city planning activities.

### **DISTINGUISHING CHARACTERISTICS**

This is the fully experienced Building Inspector class. Perform a wide range of building inspections and code enforcement duties in residential, commercial, and mobile home areas. They are required to possess substantial knowledge of the Uniform Building Code, Plumbing and Mechanical Codes, the National Electrical Code, and Title 25 requirements for mobile home construction. Assigned responsibility for weed abatement, and special assignments from the City manager.

Provides long range city planning including preparation of zoning ordinance, environmental reviews, development and maintenance of the City's General Plan, and the review of new development projects; supervises and directs through subordinates a variety of activities including hiring, performance evaluations, training, and disciplinary actions; interprets and explains city management provisions involving ordinances, rules, policies and agreements to officials, employees, and the general public; keeps abreast of all local, state, Federal and other regulatory agency laws, rules, and policies applicable to assigned programs to ensure compliance; may participate in negotiations of vendor contracts; directs the preparation and administration of the Planning Department's budget, including budget estimates and justifications; maintains cost controls to assure compliance with budget provisions; directs and assures the maintenance of records and preparation of reports necessary for program operations; prepares reports and correspondence as required.
