The Measure B Citizens Oversight Committee continues to serve as a key safeguard for transparency, accountability, and public confidence in how Measure B sales tax revenues are managed. Established through an open application process, the committee reflects a cross-section of community members who were appointed by the Colusa City Council to provide independent review and guidance.

Now in its second year of operation, the committee meets quarterly—on the second Wednesday of the first month of each quarter at 5:00 PM—to review expenditures, confirm alignment with voter intent, and offer recommendations to ensure funds are directed toward the City's highest priorities. Members serve four-year terms.

As Colusa's needs evolve and Measure B investments take shape, this citizen-led committee remains an essential part of the City's commitment to open governance. Their ongoing work helps ensure that Measure B dollars continue to deliver visible, meaningful improvements throughout the community.

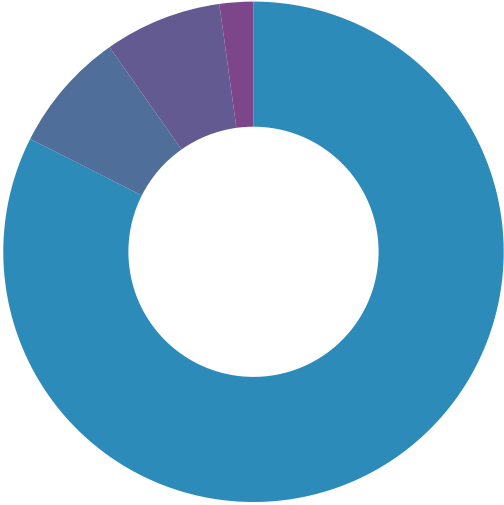
Fiscal Year 2024-2025 marks the second full year of revenue collection under the City of Colusa’s Measure B Sales Tax. This report summarizes revenue collected, funding allocations approved, and actual expenditures for the fiscal year.

During FY 2024-25, Measure B generated \$1,267,730.00 in total revenue. This figure represents total sales tax collections and is reported separately from the charts.

The charts focus on how Measure B funds were planned and spent, not total revenue:

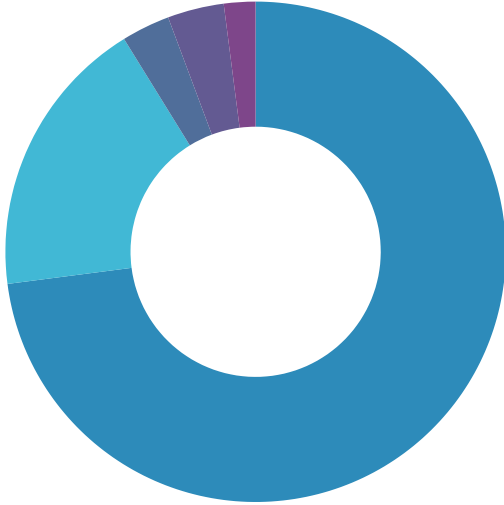
- Chart 1 shows approved allocations for the FY 2024-25 (\$897,569.00), based on Oversight Committee and City Council approval.
- Chart 2 shows actual expenditures during FY 2024-25 (\$959,569.00), including spending on projects approved in prior years.

Because Measure B funds are collected continuously while projects are approved and completed over multiple years, revenue, allocations, and expenditures do not occur on the same timeline. The City remains committed to transparent, responsible use of Measure B, supporting streets, parks, public safety, public facilities, and overall community quality of life.
